



FON JON PET CARE CAT BOARDING WAIVER AND RELEASE OF LIABILITY

THIS AGREEMENT is entered into by and between Fon Jon Pet Care ("Fon Jon") and pet owner ("Owner"): [redacted]

- 1. By enrolling the above named and described cat(s), I represent that I am the legal owner of the named cat(s) and I assume all risks, dangers and responsibility for injuries to the named cat(s). Owner understands and agrees to all invoices in relation to services rendered for said pet(s). Owner is solely responsible for any harm to Owner's cat(s) while Owner's cat(s) is/are boarding or in Day Care at Fon Jon Pet Care. [redacted] (initials)
2. Boarding extremely old, chronically ill or otherwise debilitated pets is not advisable. Special-needs pets, kittens and senior pets naturally have a higher risk of injury, stress-related illness, or exacerbation of any pre-existing condition. As such, by asking to Board your special-needs pet, kitten or senior pet with us you are waiving any claim for injury or illness experienced by your pet while in our care. [redacted] (initials)
3. Owner further understands and agrees that neither Fon Jon Pet Care, Nueva Villa Inc. nor any of its employees, staff or volunteers, nor other clients will be liable for any illness, disease, injury, death, and/or escape of Owner's cat(s). Owner hereby releases all of them of any liability of any kind whatsoever arising from or as a result of Owner's cat(s) attending or participating in Boarding services by Fon Jon Pet Care. 4. Owner further understands and agrees that any behavioral or physical health problems that develop with the Owner's cat(s) while with Fon Jon Pet Care will be handled and treated as deemed best by the employees, staff, and volunteers of Fon Jon Pet Care, in their sole discretion, and Owner expressly agrees to assume full financial responsibility for any and all expenses arising or relating thereto. This includes veterinarian services and transportation to/from Veterinarian Hospital. [redacted] (initials)
5. Owner further understands and agrees that Owner's cat(s) is/are healthy and will at all times while attending Fon Jon Pet Care Services have current/updated vaccinations. Owner is not enrolling any cat with Fon Jon Pet Care that has any condition that could potentially jeopardize the health of other cats, dogs or people and has not had any potentially communicable condition within 30 days prior to enrollment. Owner further understands that even if Owner's cat is vaccinated for Parvo Virus, Corona Virus, Parainfluenza, Hepatitis, Feline Distemper (FVRCP), Feline Leukemia (FeLV), there is a chance that the Owner's cat can still contract Parvo Virus, Corona Virus, Parainfluenza, Hepatitis, Feline Distemper, Feline Leukemia (FeLV), Upper Respiratory Disease, Feline Immunodeficiency Virus, and/or pneumonia. I agree that I will NOT hold Fon Jon Pet Care responsible if Owner's cat(s) contracts any of the diseases mentioned above. [redacted] (initials)
6. Owner further understands and agrees that Owner's cat(s) will have access to a fenced outside area. Owner agrees to assume full liability if Owner's cat escapes. [redacted] (initials)
7. Owner understands that if Owner does not pick-up Owner's cat(s) as scheduled, Fon Jon Pet Care shall be authorized to proceed according to the local municipal code governing abandonment of animals (Civil Code Sec on 1834.5). [redacted] (initials)
8. Fon Jon Pet Care reserves the right to refuse admittance to any cat or to dismiss any cat that does not meet the health, temperament or other Fon Jon Pet Care standards. The determination shall be made at the sole discretion of Fon Jon Pet Care. [redacted] (initials)
9. Owner further understands and expressly agrees that each and every of the foregoing provisions containing in Paragraphs 1-8 above shall be in force and effect and shall apply to each and every occasion on which Owner deposits Owner's cat(s) with Fon Jon Pet Care for Boarding and Daycare. This Agreement shall remain in full force and effect as between the parties until and unless otherwise cancelled or superseded by a writing signed by the parties. [redacted] (initials)

Aggressive or Dangerous Pets:

Owners MUST inform Fon Jon Pet Care if their pet(s) bite, have bitten, or are aggressive toward people, other pets, or specific grooming procedures. Muzzles may be used if necessary. Fon Jon Pet Care reserves the right to refuse or stop services for such pet(s) at any time before or during the grooming process and may charge a handling fee for Aggressive Dogs in addition to the regular grooming charge. If the pet should bite, the owner agrees to be responsible for **any and all** related medical bills, recovery costs, loss of income, and equipment damage.

Health, Medical Problems & Senior Pets:

Grooming procedures can sometimes be stressful, especially for a senior or ill pet. Grooming can also expose hidden medical problems or aggravate a current one during or after the groom. Because these pets have a greater chance of injury, they will be groomed for cleanliness and comfort. This contract/agreement gives Fon Jon Pet Care permission to obtain immediate veterinary treatment for your pet should it be deemed necessary. We will do our best to contact you first and then take your pet to the nearest veterinary clinic. All expenses for veterinary care will be covered by the pet's owner upon signing this contract/agreement.

Matt Removal:

Pets with matted coats need extra attention during their grooming session. Mats can be very difficult to remove and may require the pet to be shaved. Removing a heavily matted coat includes risks of nicks, cuts, or abrasions. Heavy matting can also trap moisture and urine near the pet's skin, allowing mold, fungus, or bacteria to grow. After effects of mat removal can include itchiness, skin redness, self-inflicted irritations or abrasions, and failure of the hair to re-grow. Shaved pets are also prone to sunburn and should be kept out of the sun until the hair grows sufficiently to protect the skin. There is an extra charge for any necessary de-matting.

Accidents:

There is always the possibility that an accident could occur. Grooming equipment is sharp, and even though we use extreme caution and care, possible injuries could occur, including cuts, nicks, scratches, or quicking of nails. Every effort will be made to ensure your pet is groomed as safely as possible.

Parasites: If fleas or ticks are found during the grooming process, your pet will receive a flea bath to kill the parasites, and an extra charge will be applied. Ticks found will be removed, and an additional charge may be applied. Parasites are a health hazard to both pets and humans.
