#### Aggressive or Dangerous Pets:

Owners MUST inform Fon Jon Pet Care if their pet(s) bite, have bitten, or are aggressive toward people, other pets, or specific grooming procedures. Muzzles may be used if necessary. Fon Jon Pet Care reserves the right to refuse or stop services for such pet(s) at any time before or during the grooming process and may charge a handling fee for Aggressive Dogs in addition to the regular grooming charge. If the pet should bite, the owner agrees to be responsible for any and all related medical bills, recovery costs, loss of income, and equipment damage. (initials)

#### Health, Medical Problems & Senior Pets:

Grooming procedures can sometimes be stressful, especially for a senior or ill pet. Grooming can also expose hidden medical problems or aggravate a current one during or after the groom. Because these pets have a greater chance of injury, they will be groomed for cleanliness and comfort. This contract/agreement gives Fon Jon Pet Care permission to obtain immediate veterinary treatment for your pet should it be deemed necessary. We will do our best to contact you first and then take your pet to the nearest veterinary clinic. All expenses for veterinary care will be covered by the pet's owner upon signing this contract/agreement.

#### Matt Removal:

Pets with matted coats need extra attention during their grooming session. Mats can be very difficult to remove and may require the pet to be shaved. Removing a heavily matted coat includes risks of nicks, cuts, or abrasions. Heavy matting can also trap moisture and urine near the pet's skin, allowing mold, fungus, or bacteria to grow. After effects of mat removal can include itchiness, skin redness, self-inflicted irritations or abrasions, and failure of the hair to re-grow. Shaved pets are also prone to sunburn and should be kept out of the sun until the hair grows sufficiently to protect the skin. There is an extra charge for any necessary dematting.

### Accidents:

There is always the possibility that an accident could occur. Grooming equipment is sharp, and even though we use extreme caution and care, possible injuries could occur, including cuts, nicks, scratches, or quicking of nails. Every effort will be made to ensure your pet is groomed as safely as possible. (initials)

<u>Parasites</u>: If fleas or ticks are found during the grooming process, your pet will receive a flea bath to kill the parasites, and an extra charge will be applied. Ticks found will be removed, and an additional charge may be applied. Parasites are a health hazard to both pets and humans. (initials)

By signing this contract, you (or your Agent) agree to hold Fon Jon Pet Care, its owners, operators, employees, and directors harmless from any damage, loss, or claim arising from any condition of the undersigned pet, either known or unknown to Fon Jon Pet Care. The terms of this agreement can change at any time, without notice, and will override any and all prior signed contracts or releases. I have read the above Agreement entirely and have had the opportunity to discuss its terms with Fon Jon Pet Care to my satisfaction and agree to its terms in its entirety.
